TERMS AND CONDITIONS WHITE BOOK CANNABISCOIN COLOMBIA

I. PRE-LAUNCH AND LAUNCH RULES

In the pre-launch of CannabisCoin Colombia there are 9"000.000 pre-mined CCC tokens available for immediate offer.

200"000,000CCC (CCC -CannabisCoin Colombia) will be pre-mined:

III. CANNABISCOIN COLOMBIA (CCC) IS A DEFLATION CURRENCY

Every 5 years the amount of CCC that will be generated during the next 5 years is reduced to 3/5.

The following projection is made based on estimates made by experts in the medical cannabis market of 2,500 "000,000 USD for the year 2025, a figure that is even higher if other industries derived from cannabis are included such as cosmetics, food and beverages, paper, textile, energy and care for the environment, construction and new materials.

There are 3,141"592,653 CCC for the first 5-year period (after launch, the market will guide its own dynamics in CCC's behavior).

- Maximum amount of CCC that can be generated (mined) during the 1st period of 5 years: 3,141"592,653 CCC divided 5 years 628" 318,530.6 CCC per year.
- Quantity of CCC generated (mined) during the 2nd period of 5 years: 1,884"955,591.8CCC (376" 991,118.36CCC per year).

- And so on every 5 years the number of tokens generated decreases, like an asymptote that tends to zero.

NOTE: Initially and for a single time, there will be pre-mined tokens, corresponding to 200"000.000CCC, allocating 100" 000.000CCC to the pioneer human resource, equivalent to 3.18% of the total amount of tokens that are mined during the first period of 5 years (3,141"592,653CCC).

- Hotel, SuperLesbiana and Psychonauts, along with personalization and Digital acquisition of each video game character through Non Fungibles Token (NFT) exclusively developed by digital artists.
2. Exchange. Platform for the exchange of cryptocurrencies such as CannabisCoin Colombia, Bitcoin and others, planning to acquire a portfolio of investments in crypto assets.
 3. Academy in Finance, Blockchain and Biotrade. In order to train the support human resource in the development of the project, as well as in the adoption and promotion of these technologies, for the transfer of knowledge and the economic empowerment of the population.
 4. Community and Association of Small, Medium and Other Cannabis Producers. Initially, small, medium and other producers are advised free of charge, in complying with the requirements and procedures in general for obtaining the cultivation license through the CannabisCoin Colombia Association, supplying the propagation material at production cost; then financing cannabis licensing and cultivation activities, along with the purchase of the harvest, providing a share of the economic benefits derived from the commercialization of the products.
 5. Technological Development Center (CDT) specialized in Cannabis and other Entheogens. Made up of professionals with masters and doctorates in different areas such as nanotechnology, bioprospecting, biotechnology, alternative energies, new materials, medical physics, among others, being responsible for the design and manufacture of the products that energize the platform of the Biotrade Virtual Store, as well as well as the monitoring of traceability and quality in the stages of the production process under the LCA approach (Life Cycle Analysis), together with the incorporation of blockchain technology for the identification of each product in a traceable way. It directs research towards the use of renewable and alternative energies, having the goal of achieving advances in the design, construction and massification of devices for the use of free energy. Supports the development and implementation of tools for Vivids Virtual Experiences (EVV) and the Cannabis Metaverse.
 6. Virtual Biotrade Store. Space for the commercialization of products derived from cannabis with high added value, manufactured in the Technological Development Center (CDT) Specialized in Cannabis and other Entheogens,

7. Cannabis Metaverse and Vivids Virtual Experiences (EVV). From the pioneer human resource, this tool is being developed for the transfer of knowledge and interaction from social marketing, as a sales strategy for the products offered in the Biotrade Virtual Store, as well as to provide the user with goods and services, a deep, intense and meaningful experience, regarding the exchange of knowledge, sensory stimulation and entertainment. These are applications for augmented virtual reality, which are developed by implementing new devices with hardware components (transducers, processing center, olfactory module, glasses and sensorial helmets adaptable to other types of products such as the Oculus and others) and specialized software, with the possibility of venturing into EVV in sectors other than the cannabis industry. It is initially planned to establish and operate in a virtual way, the Cannabis Hotel Mota together with the Cannabis Clinic and SPA, this framed in the development of the Cannabis Metaverse from CannabisCoin Colombia.
8. Comic and Video Game Mota Hotel. The scenarios take place in the dynamics of the cannabis themed Mota Hotel. It has the purpose from an ancestral, cultural, scientific and playful perspective, to provide information on the history, industry, advances and trends, in the interaction with Cannabis and other entheogens, addressing the subject in a joyful, creative, argumentative and loaded way in black humor. The main characters, co-stars and occasional characters, express different facets, highlighting positive aspects derived from the industrial, medicinal and scientific use of Cannabis and other entheogens in a utopian world. Comics and Videogames provide support to Mota Hotel, the Cannabis Clinic and SPA, making them known. They are supported in the developments of the Cannabis Metaverse and the Vivids Virtual Experiences (EVV).

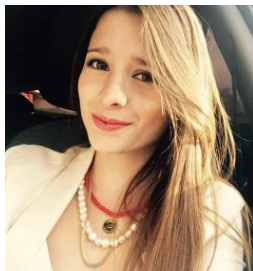

In the two previous cases, the possibilities of participating in the benefits derived from the commercialization of the finished products are minimal, there is no financing, or advice, or support for the generation and certification of processes in Good Practices.

CANNABISCOIN COLOMBIA plans to provide support so that small, medium and other cannabis producers are articulated in a fair trade scheme, with the CUMMS-GAP certification (Control Union Medical Cannabis Standard in alliance with Global Gap, they offer this organic seal and fair trade specialized in cannabis) and participating in the profits generated in the commercialization of the finished products, fully traceable from the propagation material to when the final disposal of the residues of the finished product after use is made, this through the implementation of blockchain technology.

The members of the Association will supply the cannabis biomass, which will be transformed in the CDT into finished products with high added value.

For other people and entities that want to be part of CannabisCoin Colombia without being cannabis licensees and without having any relationship with the industry, the opportunity is provided so that the Community in general that wants to join CannabisCoin Colombia can do so, for example to through the Academy in Finance, Blockchain and Biotrade. 4. Strengthening of the ExChange and Biotrade Platforms. 5"000,000CCC which, added to other resources, will allow the acquisition of equipment and software development for the consolidation of both platforms.
5. IPS Cannabis Clinic and SPA. 6"000.000CCC which, added to other resources, will allow the establishment and operation of the Cannabis Clinic and a SPA, which will incorporate, for their operation, the cannabis-derived products manufactured in the CDT. This space begins virtually with the resources collected during the pre-launch, physically materializing in a cannabis-themed hotel, providing interaction and facilitating the use of different products derived from cannabis, cosmetic, textile, paper, food and beverage lines, construction and new materials.

It is constituted as a strategy for the commercialization of products in the virtual biotrade store, in which assisted experiences are provided in real time, allowing participation in these virtual spaces, through glasses and handles to interact from augmented virtual

reality , designed in order to stimulate the sense of vision, hearing and smell (the idea being to achieve a deep interaction, translated into a great experience for the consumer, stimulating other senses depending on the product). 10"000,000CCC.

8. Strategic Investment in the Purchase of Cryptocurrencies and other Crypto Assets.
9. 10"000.000CCC added to other resources for the purchase of CannabisCoin Colombia, Bitcoin, other alcohols and crypto assets.
10. Social Project of Alternative Energy for Cryptocurrency Mining.
 - i. Blue energy in the Colombian Pacific for cryptocurrency mining. The Colombian Pacific is a region abandoned by the State, with low development indices, with areas lacking electricity, not interconnected, with abundant water resources such as rivers that flow into the Pacific Ocean, with the ideal conditions for the development of the project, for having fresh and salt water sources, as well as with enterprising locals and caretakers of the environment, mainly Afro-descendants. The installation of family gardens for food security and sovereignty is contemplated.
 - ii. Wind and solar park in La Guajira for cryptocurrency mining. Indigenous communities such as the Wayuu inhabit the Colombian Guajira, which have been deprived of the Rancherias River (their traditional source of livelihood), a river diverted for the activity of the largest open-pit coal mine in the world in The Cerrejon, operated by the foreign companies Drummond Ltd. (accused by the Colombian prosecutor's office of financing paramilitary groups) and Carbones of Cerrejón company, for this reason these communities suffer great hardships and needs, such as the death of children due to malnutrition and the consequences of paramilitary violence; Geographically this area is a desert, with the optimal conditions for the development of the project, in terms of the presence of strong winds and solar radiation during any time of the year, as well as communities eager for real alternatives for their economic empowerment.
The installation of family gardens for food security and sovereignty is contemplated.
 - iii. Energy cogeneration using heat derived from cryptocurrency mining. Through the convection heat transmission mechanism, it is possible to use a fluid to cool overheated equipment used in cryptocurrency mining (if not controlled, the thermal radiation emitted can deteriorate the equipment itself). This electrical insulating fluid will initially be at room temperature,

placing it in direct contact with the overheated units, to cool them (zero law of thermodynamics). Once the fluid increases in temperature, it is transported to the area destined for its energy use, where it can be used, for example, to heat the water in a boiler, generating steam and electricity. One of the questions that the mining of bitcoins and other cryptocurrencies that are based on proof-of-work has had, is related to the high consumption of electrical energy, which is required to power the processors that are responsible for solving complex problems cryptographic.

This would have a positive impact on the environment (cogenerated energy does not carry a coal footprint, quite the opposite) and the economy, due to the reduction in the billing associated with the electricity consumption of the equipment used in mining (the equipment would be partially powered with the same energy cogenerated during its operation).

The three above projects will be put to a vote to select the one to be funded with 5,000,000CCC (500,000USD) plus other resources.

NOTE: For the distribution of the resources collected in the following two investment rounds, the following projections will be taken into account, subject to consensus between the parties (including new investors).

X. PROJECTIONS

Cannabis Industry

- Strengthen the Technological Development Center (CDT) by acquiring robust equipment for applied research in cannabis, such as: liquid ultra-chromatography equipment with mass detector (UHPLC-MS), atomic force microscope with accessories (AFM), scanning electron microscope (ESEM), Thermal Cycler, Nanodrop, Bioreactors, among others.
- Establish and functionalize a cannabis bio factory for the production of propagation material (feminized and non-feminized sexual seed, vegetative clones, in vitro clones) and bio-inputs (including the production of stocks of lyophilized microorganisms for biological control).

- Establish and functionalize a mobile unit for the manufacture of derivatives, with an integrated analytical module, providing this service to associates.
- Based on blockchain, implement software for tracking traceability, corroborating the quality and doing the Life Cycle Analysis (LCA, ISO 14040) of the cannabis derivative products manufactured at the CDT (Technological Development Center).
- Set up and operate the Cannabis Stock Exchange, backed by Artificial Intelligence, Big Data, Blockchain and other Fin Tec (financial technology).
- Cannabis Clinic and SPA in fully operational physical facilities (in addition to its establishment and functionality in the Metaverse).
- Thematic Hotel of the Cannabis Mota Hotel, in fully operational physical facilities (in addition to its establishment and functionality in the Metaverse).

Associativity and Community

- Promote the associativity of small, medium and other cannabis producers, directing efforts towards increasing productivity, being competitive and economically prosperous; implementing cutting-edge technologies such as blockchain, the Cannabis Metaverse, Vivids Virtual Experiences (EVV), among others.
- Strengthen the CannabisCoin Colombia Community, inviting and interlocking more members, individually and in groups, for example to other universities, cooperatives, associations, etc.
- Incorporate into the productive lines of CannabisCoin Colombia, the human resource trained in the Academic of Finance, Blockchain and Biotrade; for example in the Virtual Biotrade Store, or in the Cannabis Stock Market, among other possibilities.
- To be a bridge with the sectors that require the services of high-level human resources trained in finance, blockchain and biotrade, generating employment alternatives for the graduates of the Academy.
- Formalization of the Academy in Finance, Blockchain and Biotrade as an Institution of Higher Education (IES), expanding the educational offer to formal programs by propaedeutic cycles, such as the career in Cannabis Engineering.

Energy, Blockchain and Financial Technologies

- Consolidate ourselves as our own blockchain, expanding the portfolio of services and goods.
- Consolidate ourselves as a cryptocurrency on our own blockchain.

- Make the transition to a decentralized Exchange.
- Promote the emergence of a New Sustainable, Ecological, Inclusive, Fair and Affordable Bank, based on the generation of alternative, free energy and cogeneration; together with the valorization of natural and genetic resources (for example, financing projects related to: organic crops, beekeeping, green chemistry to obtain entheogens, use of free energy, among other possibilities).
- Support from the own blockchain, the processes for the adequate and transparent management of resources in different organizations (such as companies, cities, countries, etc.).
- Investigate mechanisms for the implementation of blockchain technology in biotrade, for the characterization and sustainable use of biodiversity.
- Investigate the use of free energy, for example in applications with the Casimir Effect, with the purpose of expanding the access and use of these forms of energy. Making analogy from systems theory, economic resources are energy in our environment that corresponds to a flow of information ("Intelligent" Energy) that is nurturing and necessary for life.

- EVV for stimulation and interaction at a level that involves all the senses (vision, hearing, touch, smell and taste).
- Develop sensitive accessories for erotic encounters with real and virtual people, for example stimulating the sense of touch, with sensitive suits, or also with artifacts that simulate the torso or a full body, simulating skin characteristics (artificial skin) related to the temperature, the percentage of humidity on the surface and others that reproduce it in detail.
- Establish a direct / wireless physical connection with the nervous system, exploring possibilities in the biomedical sciences and bioengineering to take the Cannabis Metaverse and EVV to other levels.

- Develop applications with the Cannabis Metaverse and EVV in sectors other than the cannabis industry.
- Experimenting with helmets / glasses / headbands to detect nerve activity and with electrodes to electrically stimulate the cerebral cortex and other areas; doing vector electromyography, vector electrocardiography and vector electroencephalography, studying the areas in the brain and other parts of the body that are activated when under the effect of a certain entheogen. For example, in the case of psilocybin, the sensation and telepathy abilities are known as one of the effects experienced, being interesting to identify the areas that are activated when this occurs, the frequency handled in the registered wave patterns, among other possibilities. From the investigation, arriving at a directed training that allows the stimulation of these areas without the consumption of entheogens.
- Include in the CannabisCoin Colombia offer to other comics and video games, such as SuperLesbia (there is an agreement with the company Superlesbian SAS - creator of the comic and video game) and Psychonauts (in development).
- Incorporate the Cannabis Metaverse and EVV in comics and video games Mota Hotel, Psychonauts and SuperLesbian.

XI. EVV AND CANNABIC METAVERSE

An important input for the creation and development of the Cannabis Metaverse and EVV is the training and academic experience of the pioneer human resource. Highlighting the knowledge in the acquisition, processing and visualization of images, as part of the programmatic content of the Master in Medical Physics at the University of Valladolid; as well as the project of "Holographic Vectocardiography in 4D" with the ECCI University, using conceptual and practical elements related to the continuous three-dimensional projection of images (4D).

The Cannabis Metaverse and EVV are a powerful tool to market the products of the Virtual Store, providing assisted experiences in real time, allowing participants to interact in these virtual spaces, through glasses / headbands / one-piece suits (simulated skin, sensitive and intelligent), hardware elements designed to stimulate the sense of vision, hearing, smell and touch (as mentioned above, taking the experience to other senses such as touch, through one-piece suits and artificial skin). The glasses / headbands / one-piece

suit (simulated, sensitive and intelligent skin) will be massively manufactured and marketed as part of these accessories, reducing costs to facilitate the introduction and adoption of the new technology.

This strategy allows innovation, interacting at other interesting and striking levels, with potential users of the products exhibited in the Biotrade Virtual Store. It is planned to continue investing in and developing the Cannabis Metaverse and Vivids Virtual Experiences (Evv) line for Cannabis-derived products, as well as in other sectors.

Comics and Videogames, the Cannabis Mota Hotel, as well as the Cannabis Clinic and SPA, begin in a virtual way, being complementary to physical spaces, the generation of virtual spaces, in which different scenarios are related, managed and cared for in a way virtual by real people, in order to provide users with an experience that meets their expectations, regarding the use of products (medicinal, cosmetic, food, among others) in virtual spaces where they will interact with more users and with staff of human support that works there.

It is planned to use the Cannabis Metaverse and EVVs in the development of sensitive accessories that interact and stimulate the sense of touch, such as the unisex easel with a sensitive surface (intelligent artificial skin), in terms of the sensation provided by temperature and humidity, with gloves and one-piece garments (sensitive smart suits) for erotic encounters; as well as the possibility of establishing a physical connection, either wirelessly with electrodes or directly connected to the nervous system by implant, taking the Cannabis Metaverse and EVV to other levels, in search of user satisfaction and permanence.

XII. RESOURCES REQUIRED BY CANNABISCOIN COLOMBIA

The human resource together with the company Cannabis Industrial SAS, have made synergy unifying efforts to carry out activities in the different axes that make up CannabisCoin Colombia, being important for its strengthening during the first three years, the collection of contributions corresponding to 594'000,000CCC (18.9% of the total amount of tokens that are mined during the first period of 5 years, equivalent to 3,141'592,653CCC).
